

# NHS Central Register (NHSCR) Privacy Notice

# • What is the NHS Central Register?

The National Health Service Central Register (NHSCR) is a confidential population database containing information about people who were born or died in Scotland and persons currently registered or persons who have previously been registered for NHS healthcare purposes with Scottish General Practitioners (GPs). The 1939 National Register was used as the foundation for the NHSCR. For more information about the NHSCR click <u>here</u>.

#### • Who are we?

The NHS Central Register (NHSCR) is part of National Records of Scotland (NRS), a devolved non-ministerial government department headed by the Registrar General of Births, Deaths and Marriages for Scotland. The Registrar General is the controller for the personal information we process. They can be contacted via our Data Protection Officer, whose address is at the end of this notice.

## • What personal information do we process in the NHS Central Register?

The table below shows the personal information that is processed in the NHSCR. The information that can be contained in the NHSCR is determined by legislation and does not come from publicly accessible sources. The NHSCR may receive the same personal information from different sources across the UK when there is an update to a patient's record. For example, NHS numbers can be created by NHSCR or received from NHS Digital or Business Services Organisation (BSO) Northern Ireland for patients moving from elsewhere in the UK into Scotland.

# • Why do we collect your personal information?

UK legislation allows NRS to keep and maintain the NHSCR for the following reasons:

- a) to record NHS patients that register with GPs in Scotland and record patient moves between Health Boards in Scotland.
- b) to record and trigger the movement of patient medical records between Health Boards in Scotland and Health Authorities in England and Wales, notified by NHS Digital, and Health Authorities in Northern Ireland, notified by Business Services Organisation (BSO).
- c) In maintaining the NHSCR Database, NRS quality assures the data for all demographic elements (such as Sex, Date of Birth, Postcode) of information provided by GP

registration. This includes checking the data against Civil Registration Statutory Registers (Births, Marriages and Deaths), NHS Digital and Northern Ireland BSO systems.

d) the completeness and consistency of NHSCR data helps support NHS National Services Scotland (NSS) functions, decision making and planning.

# • What is our lawful basis for processing your data?

NRS's lawful basis for processing is UK GDPR Article 6(1)(e) "processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller."

Our conditions for processing sensitive information about you, are as follows:

- UK GDPR Article 9(2)(h) the processing is necessary for the purposes of preventive or occupational medicine, the provision of health or social care or treatment or the management of health or social care systems and services, supported by Schedule 1, Part 1, paragraph 2 of The Data Protection Act 2018
- UK GDPR Article 9(2)(j) the processing is necessary for archiving purposes in the public interest, or scientific and historical research purposes, supported by Schedule 1, Part 1, Condition 4 of the Data Protection Act 2018.

# • Who do we share your information with?

The NHSCR is a confidential database, accessible only to the organisations or individuals listed in legislation. The information which may be provided from the NHSCR to these bodies or individuals is the minimum necessary for them to do their work and is determined by <u>legislation</u>. So, for example, local authorities are not provided with the restricted medical research information on the NHSCR as they do not need it.

Each body listed above will become a data controller upon the receipt of the data and each will have their own lawful basis to process your data. ## • Where is your data stored?

Data held on the NHSCR database is stored securely within the UK.

## • How long is your data stored for?

The data held in the NHSCR database is stored forever for the purposes explained above.

#### • Your data protection rights

Under data protection law, you have rights including:

- $\checkmark$  The right to be informed
- ✓ The right of access you have the right to ask us for copies of your personal information.
- ✓ The right to rectification you have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- $\checkmark$  The right to restriction of processing.
- ✓ The right to object.
- ✓ The right to lodge a complaint with the Information Commissioner's Office (The ICO)

Not all of your rights may apply in all circumstances and we will deal with requests on a case by case basis. For example, the right to data portability and right to erasure do not apply as we are processing data under Article 6(1)(e) of the UK GDPR. Neither do rights in relation to automated decision-making apply as there is no automated decision making made by NRS using the NHSCR data.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

# Glossary

#### CHI database

The Community Health Index database is a register of all patients in NHS Scotland, including their CHI number. The CHI database contains details of all Scottish residents and exists to ensure that patients can be correctly identified, and that relevant information pertaining to a patient's health is available to providers of care.

## **CHI Number**

The Community Health Index number (CHI number) uniquely identifies a patient on the Community Health Index (Scotland) within the NHS in Scotland. Your CHI number is unique to you. It helps healthcare staff and service providers identify you correctly and match your details to your health records.

## Health and Social Care Public Benefit and Privacy Panel (HSC-PBPP)

The Health and Social Care Public Benefit and Privacy Panel is a governance structure of NHS Scotland established with delegated authority from NHS Scotland Chief Executive Officers and the Registrar General to scrutinise any use of NHS Scotland controlled data and NHS Central Register data.

The HSC-PBPP provides robust, transparent, consistent, appropriate and proportionate information governance and scrutiny of data access requests to ensure the Information Governance principles of safe people, safe projects, safe data, safe places are maintained.

#### **Identity Verification**

Identity verification confirms if a record exists for a living person on an extract of the NHSCR so that local authorities.

#### Linkage

Data feeds containing patient records received from other sources are linked automatically to NHSCR patient records and updated if all personal information on those records match.

#### Myaccount

Myaccount lets you use different online Scottish public sector services with one username and password. For example:

- to pay for school lunches through ParentPay and iPayimpact
- some local council services such as council tax and reporting a missed bin collection

The Improvement Service runs Myaccount for Scottish local councils.

#### NHSCR

The National Health Service Central Register (NHSCR) is a confidential population database containing information about people who were born or died in Scotland and persons currently registered or persons who have previously been registered for NHS healthcare purposes with Scottish General Practitioners (GPs). #### NHS NSS

NHS NSS is a National NHS Board. NHS NSS supports their customers e.g. territorial health boards to deliver their services more efficiently and effectively. They offer shared services on a national scale using best-in-class systems and standards. Their aim is to help their customers save money and free up resources so they can be re-invested into essential services. #### **NHS Number**

Your NHS number is unique to you. It helps healthcare staff and service providers identify you correctly and match your details to your health records.

#### **NRS Registration**

National Records of Scotland (NRS) is responsible for the arrangements for registering births, deaths, marriages, civil partnerships and other life events. For more information see <u>Registration | National Records of Scotland (nrscotland.gov.uk)</u>

## **Open Exeter**

Open Exeter gives access to patient data held on the National Health Application and Infrastructure Services (NHAIS) platform.

## **Patient Identification**

If a record cannot be matched and updated automatically, personal information fields are compared by NHSCR staff in order to identify a patient so that their record can be matched and updated manually.

# Patient Demographic Services(PDS)

The Personal Demographics Service (PDS) is the national electronic database of NHS patient details such as name, address, date of birth and NHS Number, which includes demographic information.

# **Practitioner Services Division (PSD)**

The Practitioner Services Division is part of NHS National Services Scotland (NSS). It provides patient focused services such as the transfer of medical records between General Practitioner (GP) practices, assisting patients to access GP and dental practices, as well as assisting practitioners to maintain accurate and up-to-date patient registers.

# UCRN

Unique Citizen Reference Number or **UCRN** is a number assigned to persons in Scotland at birth, or when they use certain government services.

# UPRN

**UPRN** stands for Unique Property Reference Number and was created by the Ordnance Survey (OS). It consists of numbers of up to 12 digits in length. A UPRN is a unique reference number given to every location in Great Britain with an address.
