Access to criminal case file (SC14/46/5).

NRS Response:

A sensitivity review has been undertaken on this file by the Scottish Courts and Tribunals Service. The offender has been confirmed as deceased (the statutory death certificate was traced as a result of your request) and we are able to provide the information contained in the court roll book in full. This extract details the hearing date and outcome of the summary trial (heard by the Sheriff, not a jury) held. We found two sexual offences charges against the offender in April 1970. The first entry, dated 14 April 1970 does not have plea detailed or an outcome. He was charged with the same offence on 22 April 1970, which may mean that the first hearing was not called due to lack of evidence or another administrative factor. This is the only record of this offence that appears to have been preserved by Wick Sheriff Court.

A transcription of both entries has been produced from the court roll book below. We have supplied the information requested as an extract as the information is contained in a register which contains, on the same page, many other people's sensitive data and therefore an extract is more appropriate than a heavily redacted copy.

The following is an accurate transcription from the Criminal and Quasi Criminal Roll book for Wick Sheriff Court for the dates 23 Sep 1966-14 Oct 1971 (NRS ref. SC14/46/5):
