Proactive release of information by the Scottish Government has added a considerable amount of information into the public domain from the year 2000 earlier than 15 years after it was created. This reflects releases under the Freedom of Information (Scotland) Act 2002, and complements Scottish Ministers' proactive policy of releasing historic files after 15 years. Since 2009 Scottish Government has proactively opened over 13,000 files for public inspection at 15 years.
