Testament of Heriot of Trabroun [translation of first page]

The whole inventory of the goods of an honourable man, the deceased Andrew Heriot, laird of Trabroun, made at Hoprig the 13th day of the month of May in the year of the Lord 1531 before witnesses James Schort, George Heriot, Alexander Bischop, John Congiltoun, John Hoig, Patrick Laurie, laymen, sirs Thomas Knychtsune and his curate James Mauchlyne, chaplains, with divers others.
