1. Main Points

- There were 5,646 deaths in March 2023, an increase of 11% from the previous month. The number of deaths was 10% higher than the March five-year average.
- Taking into account the size and age structure of the population, the rate of mortality was 1,199 per 100,000 population. This was 4% higher than the average rate for March.
- In March 2023, there were 526 excess deaths. People aged 80 and over accounted for 62% of all excess deaths last month. There were 2,895 deaths of people aged 80 and over which was 13% higher than average.
- The leading cause of death was ischaemic heart disease, which accounted for 12% of all deaths in March
- For females, the leading cause of death was dementia and Alzheimer's disease (13% of all female deaths in March). For males, the leading cause was ischaemic heart disease (15% of all male deaths in March).

2. Introduction

This publication focusses on mortality in Scotland, with breakdowns by council area, health board, age, sex, cause of death, location of death and deprivation quintile.

The data in this publication for 2022 onwards is still provisional and subject to change. Finalised data for the 2022 calendar year will be confirmed in July 2023.

How can these statistics used?

- To look at emerging and seasonal trends in mortality in Scotland.
- To understand excess deaths
- To investigate how causes of death, and rates of mortality vary across Scotland.

This short report only gives a look at some of the headline figures every month, with much more information available in our downloadable datasets. These datasets all have interactive charts built in, to aid users in exploring the latest trends.

The data in this report is based on the date a death occurred, other analysis can be based on the date a death was registered.

3. Differences between this data and other NRS mortality data

There are differences in the way we present deaths data in our various statistical releases. Users should consider the following factors when comparing figures from different publications.

Date of occurrence and date of registration

The data in this report focusses on deaths by date of occurrence. Other NRS datasets focus on deaths by date of registration. Deaths by date of occurrence are generally a more accurate measure as they are not affected by public holidays and other factors which may delay registration. Deaths by date of registration are more timely and can be produced more quickly, which is why we use this measure for our weekly data.

Weekly data and monthly data

The data in this report looks at monthly death data. Other NRS datasets look at weekly data. Weekly data does not fit neatly into calendar months or years, e.g. weeks 1-4 of a year are not the same thing as data for the calendar month of January.

4. March 2023 deaths were 10% higher than average





Figure 1: Number of deaths in Scotland by month, with five-year average

In March 2023 there were 5,646 deaths, which was 10% higher than the five-year average for March (Figure 1). When taking into account the size and age structure of the population, the level of mortality was 4% higher than average (Figure 2).

Excess deaths rose in March 2023, having fallen in February 2023.

Looking at excess deaths based on number of deaths suggests March 2023 was 10% higher than average levels for March, but looking at the age-standardised rate of mortality suggests mortality was 4% higher than average last month.


The year 2020 has been excluded from five year averages for the purpose of calculating excess deaths. Find out more about this <u>here</u>.

Figure 2 shows how excess based on age-standardised mortality rates is generally lower than the excess based on number of deaths. This happens because the rate takes into account the age-structure and size of the population. The population has increased over time, and has also got older (people are living longer, and there are fewer children than in previous generations). With a larger and older population, we might expect the number of deaths to be higher than it was in previous years.

The calculation of excess based on age-standardised rates takes into account the changing population structure, so it gives a more accurate picture of excess deaths by removing the impact of the growing and ageing population.

5. Most excess deaths were in people aged 80 and over in March 2023

In March 2023 there were 526 excess deaths (comparing current levels to average levels). People aged 80 and over accounted for 62% of all excess deaths last month. There were 2,895 deaths of people aged 80 and over in March 2023 which was 13% higher than average.





Over the last year, deaths have been consistently higher than average in the 80+ and 65 to 74 age groups. Deaths of people aged 64 and under have generally been closer to average levels in that time, but did increase to 17% above average in December 2022 when excess deaths were also high in other age groups.

6. Ischaemic heart disease was the leading cause of death in March 2023

In March 2023 there were 668 deaths from ischaemic heart disease, which was the leading cause of death.

Ischaemic heart disease accounted for 12% of all deaths that occurred in March 2023. This was also the top cause for males (15% of all male deaths last month), but dementia and Alzheimer's disease was the top cause of death for females (13% of all female deaths last month).




Figure 4: Leading causes of death in March 2023

7. The number of excess deaths occurring at home have been consistently higher since early 2020

The number of deaths occurring at home or in a non-institutional setting have generally increased over recent years, but increased to a higher level in early 2020 and have remained higher than average since then. In March 2023, there were 1,782 deaths at home or in an institutional setting which was 17% above average.




Figure 5: Number of deaths occurring at home or in a non-institutional setting, with five-year average

The most common location for deaths occurring in March 2023 was in hospitals (2,693 deaths, 48% of all deaths and 11% above average levels for hospital deaths). Deaths in care homes were similar to average levels last month.

8. Background Notes

Methodology

A full methodology document is available on the NRS website.

The data in this report comes from death registrations, where causes of death are certified by a doctor. Figures represent deaths occurring in Scotland, deaths of people whose usual residence is outside Scotland are included in these figures. Some data is provisional and is subject to change. This is because the cause of death (and other registered details) can be changed after a death has been registered.

10. Notes on statistical publications

National Statistics
