Title: Amendment to the services contract for the provision of an Online Collection Instrument for Scotland's Census 2021 between Registrar General for Births, Deaths and Marriages for Scotland (the AUTHORITY) and CACI Ltd (the SERVICE PROVIDER) to change to a cloud first based solution for delivering the online data collection element of the OCI services.

Originator and date of the request or recommendation for the change: Originated by the SERVICE PROVIDER in Change Request number 001 on 19 February 2018 (updated on 23 February 2018) in response to the initial discovery discussions with the AUTHORITY at the beginning of the Design and Discovery Phase 1 of this Contract.

Reason for the Contract change:
During the initial discovery discussions at the commencement of the Contract the AUTHORITY suggested the SERVICE PROVIDER could consider a <i>cloud first b</i> ased solution for delivering the online data collection element of the OCI services.
Details of the Contract change (including any specifications, milestones etc.)
The proposed change to a cloud first based solution has been mutually agreed between the AUTHORITY and SERVICE PROVIDER.

The AUTHORITY and SERVICE PROVIDER agree Section D - Approved Sub-Contractors of Schedule 4 (Management Arrangements, Implementation Plan, Key Individuals, Approved Subcontractors and Authority Responsibilities) of the Contract shall be amended to:

"The Service Provider will provide details of the Sub-contractors for this Section D within 20 Working Days of the date of this Change Control Note 001".

This is to allow the SERVICE PROVIDER sufficient time to finalise their contractual arrangements with their Sub-contractors.

The AUTHORITY and SERVICE PROVIDER further agree paragraph 4.2 of Schedule 4 (Management Arrangements, Implementation Plan, Key Individuals, Approved Subcontractors and Authority Responsibilities) of the Contract shall be amended to:

"4.2 The Service Provider shall submit a draft of the Detailed Implementation Plan to the Authority for approval within 20 Working Days of the date of this Change Control Note 001".

and

Annex 2 Charging Mechanism and Adjustments in Schedule 3 (*Pricing and Financial*) of the Contract be amended to:

"In accordance with Section A Pricing paragraph 1.2 of this Schedule the Service Provider shall submit a draft of the Milestone Payments plan for inclusion in Table 1 and Table 2 of Annex 2 Charging Mechanism And Adjustments of this Schedule to the Authority for approval within 20 Working Days of the date of this Change Control Note 001".

This is to allow the SERVICE PROVIDER sufficient time to incorporate the cloud first based solution into the Detailed Implementation Plan and the Milestone Payment Plan.

To fully incorporate this change to the solution, and to ensure the SERVICE PROVIDER has sufficient time to complete the required work in the discovery and design phase of the Contract, the AUTHORITY agrees that the time to complete Phase 1 Discovery And Design be extended by 10 Working Days of the date of this Change Control Note 001.

Price, if any, of Contract change:

None. The overall Price of the Contract is unchanged.

However, the AUTHORITY and SERVICE PROVIDER agree that Schedule 3 (Pricing and Financial) Annex 1 of the Contract shall be amended to:
