At Dundee the fifth day of August in the year Eighteen hundred and sixty two In presence of George Oliver Esquire one of Her Majesty's Justices of the Peace for Forfarshire Compeared David Lindsay Farmer Current in the Parish of Carmyllie one of the Executors of the late James Bowman Lindsay sometime residing in Dundee who being solemnly sworn and examined Depones that the said James Bowman Lindsay died at Dundee aforesaid on or about the twenty ninth day of June one thousand eight hundred and sixty two And the Deponent and John Lindsay Farmer Chamberlain know in the Parish of Carmyllie have entered upon the possession and management of the deceaseds personal Estate as Executors dative qua two of the next of kin decerned to the deceased. That the Deponent knows of no Settlement or other Writing relative to the disposal of the deceased's personal Estate or Effects or any part thereof. That the foregoing Inventory signed by the Deponent and the said Justice of the Peace as relative hereto is a full and complete Inventory of the personal Estate and Effects of the said deceased wheresoever situated and belonging or due beneficially to the deceased at the time of his death in so far as the same has come to the Deponents knowledge and that the said Estate situated in Scotland is of the value of Four [p.137] hundred pounds, and under the value of Five hundred pounds Sterling and that the deceased left no money secured in heritable property in Scotland or money secured by bonds in favor of heirs and assignees secluding Executors declared to the moveable property by the Acts twenty third Victoria Caput Fifteen Section six and twenty third and twenty fourth Victoria Caput Eighteenth All which is truth as the Deponent shall Answer to God. –(Signed) David Lindsay Goe Oliver JP
