

Consultation on the National Records of Scotland Quarterly Releases for estimates of Population By Country of Birth and Nationality for Scottish Areas and Migration between Scotland and the rest of the UK

21 June 2012

Introduction

The National Records of Scotland (NRS), formerly General Register Office for Scotland (GROS), is reviewing its quarterly outputs for estimates of [Population by Country of Birth and Nationality](#) for Scottish areas and [Migration between Scotland and the Rest of the UK](#) to ensure they meet user requirements. Comments are requested on the proposed changes outlined in this document. Please email responses to customer@gro-scotland.gsi.gov.uk by 13 September 2012. All responses received will be used to help NRS determine the timing and content of future statistical outputs on population and migration. The Office for National Statistics (ONS) is also currently reviewing some related outputs. The ONS consultation closes on 5 July and more information can be found on the [ONS website](#).

A wide-ranging NRS Demography Statistical Work Programme Consultation, which was carried out in light of the Government's 2010 Spending Review, was published on 1 December 2010 and finished on 9 February 2011. The [analysis of responses](#) received can be viewed on the NRS website. Responses relevant to population and migration received as part of the NRS Demography Statistical Work Programme Consultation will be considered alongside responses to this review.

A response to this consultation, key findings and planned changes to population and migration related outputs will be published on the NRS website in October 2012.

Topic and scope

NRS would like your views on two outputs:

1. Population by Country of Birth and Nationality

Estimates of the UK resident population by country of birth and nationality are derived from the Annual Population Survey (APS). Two tables are currently produced which are updated quarterly, these data change little from quarter to quarter.

We propose that the last quarterly release will be published in August 2012, and only annual data will be published in August each year thereafter. ONS are also proposing to move to publishing this information on an annual basis.

We would like to know:

Do you have any objections to this proposal? If so, what use do you make of the data published quarterly?

Are there any changes you would like made to how Population by Country of Birth and Nationality is presented on the NRS website?

2. Migration between Scotland and the rest of the UK

Migration between Scotland and the rest of the UK refers to people moving between Scotland and England, Wales or Northern Ireland. The main source of data used to produce NRS estimates of this sort of migration is GP registration information. Currently tables showing the total in-migration to Scotland and the total out-migration from Scotland are updated quarterly.

We propose that the last quarterly release will be published in November 2012, and only annual data will be published in July each year thereafter.

We would like to know:

Do you have any objections to this proposal? If so, what use do you make of the data published quarterly?

Are there any changes you would like made to how Migration between Scotland and the rest of the UK is presented on the NRS website?

We would particularly like to hear from regular users of our statistics. But anyone can respond and all views will be considered in full.

This consultation will be open from **21 June 2012** to **13 September 2012**.

We aim to issue a report on this consultation process in October 2012 and introduce any changes to the publication thereafter.

Where respondents have given permission for their response to be made public and after we have checked that they contain no potentially defamatory material, responses will be made available to the public in the NRS Statistical Library.
