Footnotes

1) By the Marriage (Scotland) Act 1939, which came into operation on 1 July 1940, civil marriages were introduced and irregular marriages, other than marriages by cohabitation with habit and repute, were abolished. Although two of the three types of irregular marriage were abolished in 1940 all three types of irregular marriage can be established by Decree of Declarator of the Court of Session. The irregular marriages shown in Table 7.6 are those established by Decree of Declarator of the Court of Session in the years shown although the events took place earlier.
